### **Authorisation for use of the Car Parks by Members (pursuant to By-Law 11):**

The Members who are authorised to use the car parks (“Authorised Members”) are listed as follows:

- (i) Full Members;
- (ii) Regional Members;
- (iii) Life Members;
- (iv) Country Members;
- (v) Overseas Members;
- (vi) Associate Members;
- (vii) Sailing Associate Members;
- (viii) Sponsor Members;
- (ix) Honorary Members.

1. An Authorised Member is only authorised to use one car space at any one time per membership.
2. An Authorised Member is authorised to use a single space which is not reserved in one of the car parks at all times when using the Club for recreational purposes, including;
  - (a) a Member who is a tenant;
  - (b) a Member who is also a professional sailor (ISAF Cat 3).
3. An Authorised Member who is providing a business service to another Member while on Club Premises is authorised to use the car parks at all times other than from three hours prior to the start of a CYCA scheduled race.
4. An Authorised Member who is engaged in sailing is not permitted to use the car parks for more than a continuous period of 24 Hours, unless permission has been granted in advance by the CEO of the Club.
5. An Authorised Member who is not engaged in sailing is not authorised to leave a car in the car parks if that person leaves the Club’s premises unless permission has been granted in advance by the CEO of the Club.
6. Notwithstanding anything in these guidelines a Member is not authorised to park a van, utility vehicle or commercial vehicle at any time in the small car park (other than to drop off or pick up goods and then only for a maximum period of 15 minutes) or

in the larger car park if the van, utility vehicle or commercial vehicle does not fit in one of the marked spaces.

7. A breach of the By-Laws regarding an Authorised Member's parking privileges will result in withdrawal or suspension of those parking privileges in accordance with the following provisions:
- (a)** Any Member found to have parked in a reserved space, without permission granted in advance by the CEO of the Club, will have parking privileges automatically suspended for 30 days.
  - (b)** Any Member who allows his or her membership card to be used by or for another person to park in the car parks, without permission granted in advance by the CEO of the Club, will have parking privileges automatically suspended for 30 days.
  - (c)** In all other instances of breach or repeated breach of the By-Laws regarding Member's parking privileges, a Member will be asked to attend and explain to a meeting of the Disciplinary Committee why his or her parking privileges should not be suspended or cancelled for unauthorised parking.
8. The Disciplinary Committee of the CYCA shall determine the following:
- (a)** Any request by a Member wishing to reinstate parking privileges within the automatic period of suspension of 30 days;
  - (b)** The duration of any suspension or cancellation of parking privileges.

If a Member elects not to attend a meeting of the Disciplinary Committee about his or her parking privileges the matter may be determined in the absence of the Member.

For clarification, the following classes of members do not hold car parking privileges:

- (a)** Crew Members;
- (b)** Junior Members;
- (c)** YSA Crew Members;
- (d)** YSA Junior Members;
- (e)** Provisional Members;
- (f)** Pathway Members; and
- (g)** Temporary Members.
